**Abstract:** Brown marmorated stink bug is a new, invasive pest of the western United States, following its detection and establishment in the mid-Atlantic area in the mid-1990s. In Washington, at least 14 counties have had one or more specimens reported to date. It is well established in the Vancouver area, across the Columbia River from Portland. It has been found up the I-5 corridor on the west side of the state, and is most common along the Columbia from Vancouver to Walla Walla. Detections in central Washington are confined to urban/suburban landscapes, with the exception of a few fruit orchard and vineyard detections near the Columbia. Future pest management strategies studied will include biological control with an exotic parasitoid and physical exclusion.
